BE IT REMEMBERED: That on the 6th day of July, 2016 at 7:00 PM, E.D.T., the Board of County Road Commissioners for the County of Van Buren met in regular session in the offices in Lawrence, Michigan.

Chairman Askew called the meeting to order at 7:00 PM.

No additions/deletions to the Agenda.

Motion by Ray, seconded by Svilpe to approve the Agenda.

The Chairman opened the meeting to public comment. Dan Ruzick, Antwerp Township Supervisor presented all in attendance with Antwerp Township Resolution 2016-0614 regarding the Van Buren County Road Commission's millage renewal. He asked the Board if the current allocation is what they plan to stay with? Commissioner Ray responded that since he has joined the Board the allocation has been reviewed many times with several adjustments having been made. Ray also stated he feels comfortable with allocations as being fair and equitable to the entire county. Ruzick feels "fair and equitable" is that an equal percentage is given back in return. Feels current allocation is not fair. Commissioner Svilpe and Kinney also responded accordingly as to the distribution and referenced the Township Partners Booklet. Pardike provided more detail on the allocation formula. Supervisor Ruzick's position is that Antwerp Township is "subsidizing" the rest of the county and he states that this won't continue. Ruzick asked about how charter township status would change the collection and distribution for road funding. Promise is "simply" bring the money back to where it belongs - Antwerp Township roads. Commissioner Ray finished with, Dan is serving Antwerp Township and the Van Buren County Road Commission Board has a duty to serve the best interest of the entire county road network. Pardike did remind Supervisor Ruzick that Antwerp Township has received over double the allocation of some of the other townships, such as Columbia and Hamilton. Ruzick feels that where population exists is why they should receive more of the contribution back. Equity for Antwerp Township would be 50% of revenues they generate each year and he would be elated.

Budget review was provided by Board Secretary-Accountant Pardike. Lots of work underway. Final property tax installment has been received. Lots of Federal/State Aid project bookings. Township contributions coming in from preliminary billings. Spent approximately \$2M to date on primary heavy maintenance to date (approximately 42%). Not much routine maintenance due to sealcoat operations being underway.
