BE IT REMEMBERED: That on the 16th day of January, 2014 at 7:00 PM, E.D.T., the Board of County Road Commissioners for the County of Van Buren met in regular session in the offices in Lawrence, Michigan.

Chairman Kinney called the meeting to order at 7:03 PM.

No additions/deletions to the Agenda.

Motion by Askew, seconded by Boze to approve the Agenda.

Chairman Kinney relinquished the Chair to Board Secretary, Greg Pardike, for the purpose of reorganizing the Board.

The Board Secretary called for nominations for the office of Chairman. Ray nominated Kinney for the office of Chairman. Askew nominated Boze for the office of Chairman. There being no further nominations, Secretary Pardike closed the nominations and a majority ballot was cast for Kinney.

Board Secretary Pardike called for nominations for the office of Vice-Chairman. Ray nominated Boze as Vice-Chairman. Svilpe moved that nominations be closed, and a unanimous ballot was cast for Boze.

Board Secretary relinquished the Chair to Commissioner Kinney.

Motion made by Askew and seconded by Boze to appoint Lawrence B. Hummel, P.E., as Engineer-Manager and Chief Fiscal Office of the Van Buren County Road Commission.

The Board Secretary-Accountant provided a review of the operating budgets and operating fund. He answered several questions from the Board on year-end closeouts. Noted to Board maintenance expenditures for snow and ice control for December. The primary expense was \$685,764.27 as compared to \$370,801.00 from 2012. Pardike requested that the Board recognize the 2013 budget and approve the expenditure as presented. Motion by Svilpe, seconded by Ray.

Resolution regarding equipment rental rate was brought for consideration. Commissioner Ray brought discussion on the possibility of increasing the rental rates from 110% to something more to cover potential for fully depreciated equipment. Motion by Svilpe, seconded by Boze to adopt the following Resolution:

RESOLUTION

WHEREAS: The provisions of the rules and regulations of the Michigan Department of Treasury requires that the Van Buren County Board of Road Commissioners and the Michigan Department of Transportation annually determine uniform equipment rental rates, referred to as "Schedule C", representing charges to be made by the Road Commission for the use of County Road Commission equipment against force account construction and maintenance projects; and.

WHEREAS: The Michigan Department of Treasury has provided that individual County Road Commissions may adjust the published rates in "Schedule C" to reflect either the increase or decrease in equipment costs in their particular county; and,

WHEREAS: In the opinion of the Van Buren County Board of Road Commissioners, the rental rates as set forth in "Schedule C" are insufficient to meet actual equipment expense.

NOW, THEREFORE BE IT RESOLVED: That the equipment rental rate charged by the Board of County Road Commissioners of the County of Van Buren, Michigan, for the equipment owned by said Road Commission shall be set at 110% of the published rates as shown on "Schedule C" for the year 2014.

RESOLUTION

WHEREAS: Public Act 51 of 1951, as amended, provides that the Michigan Department of Transportation shall jointly, with the Board of County Road Commissioners, ascertain and fix the total mileage of County Primary Roads and the total mileage of County Local

Roads in each county of the state which have been taken over as County Primary and County Local Roads; and,

WHEREAS: In complying with the provisions of said Act, the Michigan Department of Transportation has requested that this Board certify the mileage and location of such roads required by said Act to be fixed and ascertained.

NOW, THEREFORE, BE IT RESOLVED: That the Board of County Road Commissioners of the County of Van Buren, Michigan, does hereby certify that all of the roads on which lengths have been entered along the road bands of the attached township and enlarged section maps are normally open to automobile traffic during the months of May through October, and are under the jurisdiction of the Van Buren County Road Commission as follows:
