## **Van Buren County Board of Road Commissioners**

April 8, 2021 - Regular Meeting

BE IT REMEMBERED: That on the 8<sup>th</sup> day of April, 2021 at 5:00 PM, E.D.T., the Board of County Road Commissioners for the County of Van Buren met in regular session in person and via teleconference pursuant to the local state of emergency declared by the Van Buren County Board of Commissioners on January 26, 2021 in an effort to suppress the spread of COVID-19 and protect the public health and safety of this state and its residents, as well as the Road Commissioners and Road Commission staff.

Carey Giffen introduced herself to the Board and explained that she received a letter from the Road Commission informing her that she needed to submit a driveway permit application and a \$100 after-the- fact fee. However, she does not believe that this is a new driveway location, but an existing driveway location to which she added gravel. Ms. Giffen stated that she is "happy" to file a driveway permit application, but requested that the after-the-fact fee be waived. Discussions were held and additional questions were asked and responded to by Ms. Giffen. It was the general consensus of the Board to waive the \$100 after-the-fact fee provided that Ms. Giffen filed the driveway permit application "asap".
