Chairman Askew called the meeting to order at 7:00 PM.

No additions/deletions to the Agenda.

Motion by Boze, seconded by Ray to approve the Agenda.

The Chairman opened the meeting to public comment. Wendy McKenzie addressed the Board and those present regarding her mother's issue at 35340 - 60<sup>th</sup> Avenue. She spoke of concerns about drainage that was "left" after work was completed last summer. Driveway restricts the parking for their commercial business according to Ms. McKenzie. The Board indicated that several members will review her concerns.

Board Secretary-Finance Director Rader provided a review of the operating budgets and operating fund. She provided an update on the bills before the Board tonight. Pavement marking invoice is nearly \$175,000.00 for first round of painting. 1,042 tons of hot mix was put down in the last two weeks at a cost of approximately \$45,000.00 for the materials only.

A discussion was held with a review provided by Hummel, Rader and Anttila, regarding proposed additional Primary Road work as follows:

- CR653, Pine Grove Township, culvert replacement (\$113,000.00)
- CR653, Almena Township, top course paving (\$118,000.00)

- CR352, Decatur Township, crush and shape (\$155,000.00)
- Primary Seal, +/- 10 mi. (\$285,000.00)

Motion by Ray, seconded by Boze to authorize the Engineer-Manager to award the bid, in the best interest of the Van Buren County Road Commission and Decatur Township, upon tabulation, review and recommendation by the Engineering Department.

An update was provided by Engineer-Manager Hummel on the award of the bid for heavy maintenance work on 68<sup>th</sup> Street over the Camp & Root Drain, Hartford Township, to Brad Thomas Excavating, in the best interest of the Van Buren County Road Commission and Hartford Township.

A conceptual review of the proposed Village of Lawrence "Safe Routes to School" trail project was presented by Hummel. The Board discussed and unanimously agreed not to authorize the requested easement. Their position was such that the Village should maintain the proposed route to the East of the Van Buren County Road Commission's property; mostly on ISD property. Motion by Ray, seconded by Boze.

A discussion was presented by Hummel regarding the proposed transfer of jurisdiction of a portion of Phoenix Road to the City of South Haven. Rader and Anttila provided details on investments made since 2006 by the Road Commission. On a consensus, the Board authorized staff to move forward with negotiation on the jurisdictional transfer.

Discussion held regarding Primary Road Program and millage as presented by Rader, Anttila and Hummel.
