WHEREAS, the Plat of Edgewood, being a subdivision in part of the Southwest Quarter of Section 21, Town 3 South, Range 13 West, Antwerp Township, Van Buren County, Michigan, described as follows:

FROM THE WEST QUARTER CORNER OF SECTION 21, TOWN 3 SOUTH, RANGE 13 WEST, MEASURE \$89°22'06"E, ALONG THE EAST AND WEST QUARTER LINE OF SAID SECTION, 1326.73 FEET TO THE POINT OF BEGINNING OF THE LAND HEREIN DESCRIBED; THENCE CONTINUE \$89°22'06"E, ALONG SAID EAST AND WEST QUARTER LINE OF SAID SECTION 378.55 FEET; THENCE \$00°30'55"W 333.00 FEET; THENCE \$89°22'06"E, PARALLEL WITH THE EAST AND WEST QUARTER LINE OF SAID SECTION, 400.00 FEET TO A LINE PREVIOUSLY CALLED 486.7 FEET WEST OF THE NORTH AND SOUTH QUARTER LINE OF SAID SECTION; THENCE \$00°29'56"W, ALONG SAID LINE, 561.85 FEET TO A LINE PREVIOUSLY CALLED THE SOUTH LINE OF THE NORTH \$95 FEET OF THE SOUTHWEST QUARTER OF SAID SECTION; THENCE \$N89°21'27"W, ALONG SAID LINE, 778.28 FEET TO A LINE PREVIOUSLY CALLED THE WEST LINE OF THE EAST 1265.40 FEET OF THE SOUTHWEST QUARTER OF SAID SECTION; THENCE \$N00°29'13"E, ALONG SAID LINE, 894.71 FEET TO THE POINT OF BEGINNING. CONTAINING 12.93 ACRES. THIS PLAT CONSISTS OF 13 LOTS.

WHEREAS, Edgewood Circle lies within the Plat of Edgewood, situated in Antwerp Township, Van Buren County, Michigan; and,

WHEREAS, Edgewood Circle meets the requirements and provisions as set forth in the Van Buren County Road Commission's Road Development Policy, including standards for road right-of-way; and,

WHEREAS, it is in the best interest of the soon-to-be residents of the Plat of Edgewood, the motoring public, Antwerp Township, and the Van Buren County Road Commission to certify the roadway, as set forth herein.

NOW, THEREFORE, BE IT RESOLVED that the following roadway located within the Plat of Edgewood is hereby certified as a county local road: Edgewood Circle from 62nd Avenue South 823 feet (0.16 mi.) to the cul-de-sac.

IT IS FURTHER RESOLVED that a copy of this Resolution shall be recorded in the office of the Register of Deeds for the County of Van Buren.

IT IS FURTHER RESOLVED that a copy of this Resolution shall be published once each week for three (3) successive weeks in the *Kalamazoo Gazette*, a newspaper printed and circulated in the County, and the Affidavit of Publication shall be filed with the Clerk of Van Buren County and the Clerk of Antwerp Township.
