Chairman Askew called the meeting to order at 7:03 PM.

No additions/deletions to the Agenda.

Motion by Ray, seconded by Boze to approve the Agenda.

Moved by Kinney and seconded by Svilpe to approve the minutes of the June 1, 2016 meeting as presented by Board Secretary Pardike.

The Chairman opened the meeting to public comment. John Vargo requested that the Board send a letter to Hartford Township resident for taking care of correcting drainage west of 60th Street. Also look at 64th Avenue "swamp" in fall. Feels that water has no outlet. Water is "closing in on the roadway".

The Board Secretary-Accountant provided a review of the operating budgets and operating fund. Expecting the remaining millage levy revenues. It appears that due to an unusually high delinquent tax collection, additional funds are expected in addition to that which was budgeted. Lots of activity on Federal/State Aid projects. It appears as though township contributions may reach \$3.6M this season. Sealcoat operation is up and going with first liquid cement bill in today's voucher. Hummel reviewed the petition request that has been re-submitted by the residents of Paw Paw Township on 51st Avenue from CR665 East to the dam for temporary speed hump installation. The Board directed Hummel to send a letter to their representative denying the request due to the non-standard nature of a speed hump in the roadway.

On a motion by Ray, seconded by Boze the following Resolution was adopted:

RESOLUTION

WHEREAS: On June 30, 2016 Kenneth Tomsa will retire from his position as a Road Maintenance Employee for the Van Buren County Road Commission; and,

WHEREAS: Kenneth Tomsa began his employment with the Van Buren County Road Commission on April 15, 1996. He remained a dedicated employee for 20 years and two months working as a truck driver; and,

WHEREAS: As a Road Maintenance Employee, Kenneth Tomsa also performed winter maintenance operations, including snow removal and ice control, very often through brutal conditions, for the benefit of the motoring public throughout Van Buren County.

WHEREAS: Kenneth Tomsa was a dedicated member of the Road Commission staff who performed his duties with great pride and dedication, and always in the best interest of the citizens of Van Buren County, and the Van Buren County Road Commission.

NOW THEREFORE BE IT RESOLVED: That the Board of County Road Commissioners of Van Buren County recognizes the dedication of Kenneth Tomsa and wishes him the very best in his retirement years.

Engineer-Manager Hummel updated the Board on the award of bids to the as-read low bidder, Michigan Paving & Materials, as follows, in the best interest of the Van Buren County Road Commission and the respective townships:

- 60th Avenue, Paw Paw Township (\$342,338.75)
- 39th Street, Decatur Township (\$162,500.00)
- 68th Street, Bangor Township (\$58,580.35)

Hummel and Pardike provided some historical perspective on the county-wide millage allocation process and revenue stream. The Commissioners voiced their opinions on the current process and felt that they have reviewed allocations in depth over the last few years and that they believe the system works. Three of the last four years the township local road pot was increased. The formula is a fair and equitable system for distribution of funds across the county, in the best interest of the county-wide road network. The Board is committed to continuing their annual review of process and allocations, in the best interest of the entire county. (See Page 2 of Township Partners Booklet).

Road Commissioner's Township Meeting Attendance Report

From June 1st to present:

Askew: South Haven Township, a resident questioned about signs for Fire Lane A, which is private. Staff will review the areas of 13th and 14th Avenues. Bangor Township, township is okay. County Roads need more attention. Covert Township, okay. Geneva Township, concerned over roadside mowing schedule. When is mowing going to be done? What is status of down guardrail? Askew presented staff with a list from the township.

Boze: Keeler Township, reported light out in Keeler (CR6887 at CR352 West). Contractor is to be relocating in the coming weeks. Lawrence Township, going well. Hartford Township, going well. Hamilton Township, 46th Street at 76th Avenue intersection, questioning if eligible for safety funds? Passed a Resolution in Support of the county-wide road millage.

Kinney: Decatur Township, voted to add Valley Road to local seal coat this year. Complaints about Old Swamp Road being so rough. 80608 Stapleton Road, Susie Roehm concerned about dead tree too close to road needing removal. Appreciated the bid price on 78th Avenue.

Ray: Pine Grove Township, concerns over the millage allocation process. Informed them of status of CR653 contract letting. An issue on corner of 12th Avenue and 26th Street (NW corner). Large field comes into intersection is eroding material into roadway. Staff is looking into ditch work. Requested more frequent mowing on 27th Street, 28th Street and 29th Street. Bloomingdale Township, request to mow earlier as they feel they are having vision issues seeing stop signs. Can the order of mowing in the county be revised? Possibly require the contractor to perform in a more timely fashion. Concerned over timing of dust control.

Svilpe: Antwerp Township, the Supervisor presented the issues he feels need to be addressed by the Board.

Engineer-Manager Hummel read the Highway Engineer's report as follows:

- 32nd Street, Porter Township, HMA top course placed on 6/6/16. Shoulders placed on 6/16/16. Restoration and striping yet to be completed.
- Fox Creek Subdivision, Antwerp Township, HMA ultra-thin and wedge paving completed on 6/2/16 and 6/3/16. Restoration to be completed.
- 64th Avenue, Antwerp Township, M-40 east to 30th Street, HMA ultra-thin placed on 6/2/16, shoulders placed on 6/16/16.
- 48th Street, Arlington Township, culvert installed today 6/16/16 on Scott Lake Drain immediately south of 24th Avenue.
- 51st Avenue, Lawrence Township, culvert replacement to begin 6/17/16 on Nelson Lake Drain.
- CR653, Almena Township, culvert to be delivered Monday. Waiting on schedule from contractor.
- CR681, 71st to 77th, HMA top course placed on Monday. Shoulder gravel yet to come.
- CR681, 77th to CR352, base paving completed on 6/10/16.
- Red Arrow Highway, HMA base course completed. Paving today and tomorrow with fabric.
- CR687 bridge is underway, as well as a part of the 8 bridge rehabilitations.
- We will open bids on the following projects at our next board meeting: CR376 trenching, widening and restoration; CR380 trenching, widening, crushing and shaping, and new HMA; and, Sand Pines Subdivision, Antwerp Township, HMA overlay with restoration.
