RESOLUTION NO. 2019-04

From January 17th to present:

Askew: None.

Boze: Attended Keeler Township on 2/5. The Keeler Township Fire Department thanked the Van Buren County Road Commission for salting the road during the fire at the old Klett plant building.

Burleson: Met with Bloomingdale Township's supervisor. Had several questions to relay to staff for a response. Burleson also thanked the Road Commission staff for clearing the roads on Thursday for the funeral of the young Serviceman in Bloomingdale. It was greatly appreciated by all in attendance.

Kinney: KATS on 2/6.

Moffat: Decided to cancel his attendance at the Asset Management training due to inclement weather. Checked out Antwerp, Almena and Porter Township roads during the recent winter storms. He felt staff kept up pretty well, but notes that the roads were covered with snow three hours later. Commissioner Burleson commented that Road Commission staff performed their duties as well as they could given the extreme conditions. The roads were widened up as fast as staff could get to them.

Moffat also reported that Antwerp Township called him to ask what was going on at Red Arrow Highway. Moffat called the Road Commission and was advised by staff that it was preliminary survey work. Discussion held that the Road Commission notifies townships once projects have more assured funding, the scope is determined and there is some sort of timeline to share. Moffat stated that Antwerp Township wanted it noted that, in the future, they would like notice of work.
