General Information

The citizens of Van Buren County have supported a road millage since 1978 when it was first approved. It was last renewed in 2016.

The road millage provides funds for the purpose of maintaining, repairing, and constructing public streets, avenues and roads in Van Buren County. In fact, the funds from the county-wide road millage are a substantial part of the annual road budget for the Road Commission, and for all cities, villages and townships located in the County.

In addition, because a major portion of the road work is completed by local contractors, this millage helps to keep jobs right here where we need them: in Van Buren County and the surrounding localities. Better roads and bridges save time, save lives, and save money.

Do You Know ...

The County-Wide Road Millage Proposal is to RENEW the expiring millage for roads. The Proposal seeks to renew a 0.9769-mill for four years. For a home with a taxable value of \$61,000 (\$122,000 market value), the mill would cost a homeowner approximately \$60.00 annually. These millage dollars are spent directly on repairing and constructing roads in Van Buren County. These millage funds are not spent on routine maintenance operations, such as snow removal, pothole filling, pavement marking, roadside mowing, tree removals, etc. as they are funded by fuel tax and vehicle registration fees.

By defining how these road millage dollars can be spent the Road Commission has been able to make improvements to the county-wide road network to help meet the needs of its citizens.

The Road Millage is Vital to Van Buren County Roads

It may come as a surprise to learn that road commissions receive almost all of their revenues from fuel taxes and vehicle registration fees through the State of Michigan Transportation Fund (MTF). These funds are what the Road Commission utilizes in its routine operations to maintain the county road system which consists of 1,328 miles, including 66 bridges.

How can I learn more about the proposed Road Millage renewal?
